


#### **GDP Overstates Recent Weakness**



\* First principal component of 56 key weekly and monthly US economic indicators. Source: Goldman Sachs Global Investment Research.




### Global Economic News Has Improved




### ...But FCI Impulse Should Improve Sharply



<sup>\*</sup> Assumes GSFCI remains constant at April 13 close. Source: Goldman Sachs Global Investment Research.




# **Core Inflation Trends Normalizing**
